

## COOKIE POLICY

In this Cookie Policy, we refer to Courante BV and 'Website' refers to datamachine.nl, datamachine.info, datamachine.io and datamachine.online. This policy covers cookies and similar technologies that may be used in connection with the use of the Website

### **1.1 What are cookies?**

A cookie is a simple text file stored on your computer or mobile device. It contains anonymous information such as a unique ID, the name of the website or app and some numbers and characters. This allows a website or app to remember some things such as who you are, what your preferences are or what is in your shopping basket. When we refer to cookies in this policy, we are also referring to similar technologies.

Most websites you visit use cookies to enhance your user experience by enabling the website to 'remember' you. To learn more about cookies, please click [All about cookies](#).

### **1.2 How long are cookies stored?**

Cookies are stored for different periods depending on what they are used for:

- Session cookies are temporary cookies and are only stored until you leave the website or close the web browser or app.
- Persistent cookies remain stored for a fixed period, as defined in the cookie, and enable a website or app to recognise the device again when the user returns to that website or app on that device.

### **1.3 How do we use cookies?**

The Website uses a number of first-party and third-party cookies:

- First-party cookies are placed and set by us. These may serve to monitor the performance of our the Website, to ensure that the Website works properly and/or to store your preferences regarding the Website.
- External cookies are set and set by our selected third parties. These may serve to perform measurements of a website or app, to perform an external service on the website, or to enable third parties to deliver relevant advertisements. These third-party cookies are used by approved organisations, which have their own privacy policies, on the Website.

Cookies enable us and, where applicable, third parties to gather information about your visits to and use of the Website. The cookies we set can be grouped into the categories below:

- Required cookies

These cookies are crucial and enable you to use the Website and their features. Without these cookies, we cannot provide the services you have requested the ability to stay logged in when you use the Website.

- Functional cookies and performance cookies

These cookies collect information about how visitors use the Website, such as which pages visitors browse to most often and whether they receive error messages. They also enable the Website to provide the services you have requested, they remember the choices you make (such as your username and preference settings) and they remember whether you have visited or used the Website in question before. All information collected by performance cookies is aggregated and used exclusively to improve the operation of the Website. The information collected by functional cookies may be anonymised, and they cannot track your browsing activities on other websites.

## **1.4 How to manage cookies**

- Browser settings

You can change your cookie settings in all major browsers - for example, you can set your web browser to notify you when you receive a cookie, giving you the opportunity to decide whether or not to accept it. You can usually find these settings in your browser's 'options' or 'preferences' menu. The links below may be useful for better understanding these settings. You can also use the 'Help' option in your browser if you need more help.

You can also delete all cookies that are on your device and prevent them from being set again. If you do this, you may have to manually adjust some preferences when you visit a website, and some services and features may no longer work.
